The State Attorney, by and through the undersigned Designated Assistant State Attorney, further charges that a person identified as KRISTIN EVANS is a family or household member in accordance with Florida Statute 741.28.

COUNT TWO

WORRELL, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that ZACKARY LATRELL STACY, on or about the 16th day of August, 2021, in said County and State, did, in violation of Florida Statute 784.03(1)(a)(1) or 784.03(1)(a)(2), commit a battery upon a person identified as KRISTIN EVANS, and in furtherance of said battery, the said Defendant did actually and intentionally touch or strike a person identified as KRISTIN EVANS, against the will of a person identified as KRISTIN EVANS or did intentionally cause bodily harm to a person identified as KRISTIN EVANS. The State Attorney, by and through the undersigned Designated Assistant State Attorney, further charges that a person identified as KRISTIN EVANS is a family or household member in accordance with Florida Statute 741.28. The State Attorney, by and through the undersigned Designated Assistant State Attorney, further charges that the crime of domestic violence took place in the presence of a child under 16 years of age who was a family or household member of the victim or the perpetrator in accordance with Florida Statute 741.28 and 741.283.

COUNT FOUR

WORRELL, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that ZACKARY LATRELL STACY, on or about the 16th day of August, 2021, in said County and State, did, in violation of Florida Statute 806.13(1)(b)(1), willfully and maliciously injure or damage certain real or personal property, to-wit: a pool, the property of KRISTIN EVANS, as owner or custodian.
