On Sunday, April 16th, 2023, at approximately 1200 hours, I responded to Walmart, located at 8500 North Wickham Road, Melbourne, Brevard County, in reference to a male that Walmart Loss Prevention requested to be trespassed.

Upon my arrival, contact was made with Loss Prevention employee [REDACTED] who stated the following in summation:

Since approximately 1030 hours, LP [REDACTED] was walking around the business when he observed a white male, later identified as David Knight, walking around the business with a shopping cart. LP [REDACTED] noticed Mr. Knight was following young juvenile girls while pushing a shopping cart. It was at this time that Mr. Knight would take out his cell phone and proceeded to take photographs of these young girls while he was walking behind them. After Mr. Knight had taken the photos, he would walk around a corner in the business and then place his hands down the front of his pants and appeared to be touching his genitals inappropriately in a lewd and lascivious behavior.

LP [REDACTED] observed Mr. Knight conduct this behavior with multiple young girls from approximately 1030 hours to 1158 hours. Once LP [REDACTED] was positive that Mr. Knight was apparently masturbating in public, he called 911. LP [REDACTED] provided a sworn signed general affidavit.

I then observed Mr. Knight, after receiving a brief description of the male, at the self-check out isles. LP

[REDACTED] confirmed he was the male in question. I then subsequently detained Mr. Knight.
 Contact was then made with Mr. Knight inside the Loss Prevention office.
 In a post Miranda interview, Mr. Knight admitted to taking photos of young girls inside the business and he would later masturbate after taking the photos. Mr. Knight advised he was inside the store for over an hour, masturbating multiple times to multiple young girls. Mr. Knight consented to a search of his phone in which I observed a photo of a young female. Mr. Knight stated he believed her to be at least [REDACTED] years of age when he had taken a photo of her and masturbated near her presence. Mr. Knight advised that he is currently wearing a sex toy around his penis while he conducted these acts.
 Mr. Knight also advised he has been conducting this behavior for approximately over one year. Yesterday morning on April 15th, 2023, Mr. Knight advised he arrived at this aforementioned location and performed the same lewd lascivious acts without being detected by Walmart staff.
 Contact was later made with the young female I observed in Mr. Knight's phone, hereinafter referred to as MA, and [REDACTED]. It was later confirmed that young juvenile is approximately [REDACTED].
 Based on my investigation, there is sufficient probable cause to charge Mr. Knight with lewd lascivious behavior, disorderly conduct, and aggravated stalking of a child under 16 years of age.
 Mr. Knight was subsequently placed under arrest and transported to the Brevard County Jail without incident.
