Contact was later made with the young female I observed in Mr. Knight's phone, hereinafter referred to as MA, and It was later confirmed that young juvenile is approximately Based on my investigation, there is sufficient probable cause to charge Mr. Knight with lewd lascivious behavior, disorderly conduct, and aggravated stalking of a child under 16 years of age. Mr. Knight was subsequently placed under arrest and transported to the Brevard County Jail without incident.
