CASE DETAILS:

I was dispatched to Third Ave. in reference to a disturbance.

INVESTIGATION:

Upon arrival to Third Ave. I walked into the home and saw two small juveniles playing in the living room. The young boy met me at the door. I asked him did someone call the police and he stated they are in the bedroom.

I walked through the living room and through the kitchen. I looked into the bedroom door that was partially open and saw a blood on the bedroom floor.

I went into the room and saw holding Jennifer Kirk as he was laying over her.

Sgt. Cox went into the room in front of me and advised me that to help him get out of the room so he could see what's going on (see Sgt Cox's supplement).

Sgt. Cox advised me to have EMS enroute as well as Investigator Milliette. I advised dispatch to have EMS enroute as well as Milliette.

came out of the bedroom and immediately went on his knees on the kitchen floor. was wearing tan pants and a plain white t-shirt. was covered in blood.

was sobbing and was hard to understand. I asked what happened and he stated that he was in the living room when he heard a gun shot and he went into the bedroom and found Jennifer Kirk on the bedroom floor.

I was unable to get any more information from as he was sobbing loudly.

EMS arrived and pronounced her deceased at approximately 1808 hours.

I then took to my patrol car to have him wait until we could secure the scene.

I then took to KRJ to wait to be interviewed by investigator Milliette.

CASE STATUS:

Case turned over to Inv. Milliette for follow-up.

On 05/23/2018, at approximately 1801 hours, dispatcher in reference to his neighbor, police right away for an unknown disturbance.

; called the Kotzebue emergency going over and asking him to call the

Officer Cook and I responded to Third Avenue in reference to this call and upon arrival, we made entry into the residence and were greeted by two juveniles in the living room. The juveniles stated their dad was the one that needed police and he was in the bedroom. Officer Cook and I went to the bedroom and could hear crying. The bedroom was located in the northeast corner of the residence.

Officer Cook made entry into the bedroom and noticed blood on the floor; as well as, laying over the top of a female crying. I made entry and had to leave the room so I could assess what was going on and provide medical attention to the female, later identified as Jennifer Kirk. complied and walked out of the bedroom. I visibly observed that hands, arms, shirt, and pants were covered in blood. There also was blood splatter on the floor in the bedroom, on a dresser located in the bedroom, the mattress, blankets, and on several plastic totes.

I then observed Jennifer laying on her right side in a semi "fetal" position. Her left arm was almost in a 90 degree angle and she was bleeding heavily from her head. I then observed a .22 caliber bolt action rifle laying at her feet, partially over her left foot. It was visibly obvious that Jennifer was deceased.

I had Officer Cook to inform dispatch to have EMS to respond; as well as, Investigator Milliette. EMS arrived on scene at 1807 hours, and Jennifer was pronounced dead by KFD fire chief Brian Reiselbara at approximately 1808 hours.

All occupants were removed from the residence and the scene was secured for Investigator Milliette's arrival. Investigator Milliette arrived on scene and took over the investigation. I assisted Investigator Milliette as needed with moving Jennifer's body position for photographs etc.

Investigator Milliette processed the scene for his investigation and afterwards he and I went to MHC where Jennifer's body was placed in the morgue pending transport to the medical examiner's office in Anchorage. The cooler Jennifer's body was placed in was secured and sealed with tag #0010959.

CASE DETAILS:

On 05/23/2018 at approximately 1808 hours, I received a phone call from the Kotzebue emergency dispatcher regarding a gun shot at Third Ave. in Kotzebue.

OFFICERS OBSERVATIONS/ACTIONS:

At approximately 1813 hours, I arrived at the residence of Third Ave. where I contacted Kotzebue Police Department (KPD) Sergeant Cox and Officer Cook. My contact was recorded and a copy of the recording was later entered into evidence. Upon entering the residence, I observed a male who was later identified to me as seated on the floor of the kitchen. I observed to have what appeared to be blood on his hands and his clothing. was crying hysterically and wouldn't speak with me. Sgt. Cox led me into a bedroom where I observed a female laying on the floor, at the foot of a bed, in a semi-fetal position. I further observed a rifle lying on top of her left leg with the muzzle near her buttocks. I observed the bedroom to be located in the North East corner of the residence.

I asked Ofc. Cook and Sgt. Cox if they would escort out of the residence and place him in a patrol car to prevent him from disturbing the scene.

I returned to the room which I identified as being a bedroom. I did not notice the smell of alcohol and I did not observe alcoholic beverage containers or illegal narcotics/prescription medications. Sgt. Cox identified the female to me as being Jennifer Kirk. I took initial photographs of the bedroom which were later entered into digital evidence.

I departed the residence and went to the police department where I obtained evidence collection supplies and returned to the residence.

Upon returning to the bedroom, I photographed the scene and contacted the State of Alaska Medical Examiner's Office (SMEO). I spoke to Inv. Masson about my observations and he authorized me to move Jennifer.

I observed the firearm to be a Marlin .22 magnum bolt action rifle and the safety to be set to fire. I observed a magazine in the firearm which had ammunition loaded. I opened the bolt of the rifle and observed one spent rifle casing in the extractor on the bolt. I noted the length of the rifle from the tip of the barrel to the tip of the trigger as being 27 1/8 inches long and an overall length of the rifle as being 41 1/8 inches. Further, Sgt. Cox and I measured Jennifer's arm length and noted it as being approximately 26 3/16 inches in length.

I observed what appeared to be a bullet entrance wound located under Jennifer's chin that was approximately 3/8 inches in size. I also observed what appeared to be a circular imprint around the entrance wound which resembled the end of barrel of the rifle located with Jennifer. The entrance wound was photographed. I did not observe an exit wound.

I noticed Jennifer's lower jaw could move suggesting rigor mortis had not set in and I did not observe lividity. Additionally, Sgt. Cox informed me Jennifer's body temperature appeared warm on her lower back. Jennifer was later removed from the residence and transported to Maniilaq Health Ce

nter (MHC) where she was placed in the morgue.

At approximately 2034 hours, I arrived at the Kotzebue Regional Jail in reference to speaking with . My contact was recorded and a copy of the recording was later entered in evidence. I read the Miranda Warning from my department issued card and he agreed to speak with me.

INTERVIEW:

In essence told me he was watching television with his kids and he heard a "pop". then discovered Jennifer in the bedroom, he went to a neighbor's house and told them to call 911. also told me Jennifer was still breathing when he found her. Further, told me I could have the bloody clothing he was wearing. later told me was unable to talk to me at the moment, but he would talk with me later.

OFFICERS OBSERVATIONS:

I collected clothing and later transported them to KPD where they were entered into evidence. left the jail on his own accord.

On 05/24/2018 at approximately 0933 hours, Ofc Cook and I arrived at MHC to move Jennifer to the lower cooler at MHC due to concerns the cooler she was originally placed in was not regulating the correct temperature. I noted the seal on the cooler as being intact. Once Jennifer was moved to the secondary cooler, I attached a new seal bearing number 0010958.

On 05/25/2018 at approximately 0815 hours, the SMEO contact me and advised Jennifer's remains showed signs of strangulation.

At approximately 0837 hours, I contacted by phone and requested an interview with her.

At approximately 0904 hours, arrived at KPD. My contact was recorded and a copy of the recording was later entered into evidence.

INTERVIEW:

In essence told me has been staying at her residence, he has just been staying in the room and he hasn't talked too much. asked what had happened when they picked him up and he stated he was watching cartoons with the kids in the living room and heard the gunshot. ran in to see what happened and she was on the bed.

told me and Jennifer's relationship has been on/off again since 2011. They have two kids together, and who just left to Buckland. Jennifer is but she is really her . Jennifer's biological parents are r and ; Jennifer's adoptive parents are and Kirk.

told me the last time she saw Jennifer was on 05/21/2018. When saw Jennifer on the 21st, did not observe any bruises on Jennifer. Jennifer had been trying to be sober. told me the last time she knew of assaulting Jennifer was last fall. told me she has known Jennifer

to become intoxicated and "accuse" of hurting her and it was hard to believe Jennifer sometimes.

told me the last time she spoke to Jennifer was 05/23/2018 at approximately 1430 hours. Jennifer had asked if would drop off some diapers to them. told me Jennifer sounded like she may have been consuming alcohol, but she wasn't sure. Jennifer again called her about one hour later requesting diapers, but was at work. told me had brought diapers over to Jennifer and got home at approximately 1700 hours and asked if they were consuming alcohol and he thought they were. estimated had gone to Jennifer's at approximately 1600 hours. stated to her that the kids were alright and Jennifer and Anthony were consuming alcohol. informed me claimed she had seen Jennifer with her two children walking back to the house prior to the incident and Jennifer did look intoxicated.

According to , Jennifer was happy to be back together with and Jennifer had been in another relationship in Buckland. told me that had told that he and Jennifer were planning on getting married.

was unfamiliar with Jennifer having past tendencies of suicide, but when Jennifer consumes alcohol she cries and makes accusations. According to , is "really easy going" especially when he is consuming alcohol and when they started seeing each other, began getting into trouble.

told me Jennifer had a "black eye" and Jennifer claimed she was "jumped" over the weekend by and further told me Jennifer's right eye was black and that Jennifer had texted her on 05/16/2018 about the assault.

OFFICERS OBSERVATIONS/ACTIONS:

allowed me to photograph the text messages between and Jennifer. The photographs were later entered into evidence.

INTERVIEW:

In essence told me the only thing had said was he was watching "SpongeBob" with the kids in the living room. told me she would go home and have come to KPD to speak with me.

OFFICERS OBSERVATIONS/ACTIONS:

My contact with concluded and departed KPD.

At approximately 0932 hours, arrived at KPD to speak with me. My contact with was recorded and a copy of the recording was later entered into evidence.

In essence [redacted] told me the last time he saw [redacted] and Jennifer was when he was at their house at approximately 1600 hours and they were not arguing. [redacted] told me [redacted] is his [redacted] and [redacted] is currently staying with him at his residence. [redacted] told [redacted] he was watching television with his kids and he heard what sounded like a firecracker go off in the bedroom. [redacted] did not tell [redacted] what was going on prior to him watching television. [redacted] told me Jennifer had a black eye on her face from being "jumped" by a minor, but he didn't know when it happened. [redacted] and Jennifer planned to get married; however, he has heard them argue before. [redacted] told me the .22 magnum rifle was [redacted], his

OFFICERS OBSERVATIONS/ACTIONS:

I noticed my audio recording device shut off so I changed the batteries and resumed recording.

INTERVIEW:

In essence [redacted] told me last weekend Jennifer and [redacted] were arguing and Jennifer was talking about suicide while she was intoxicated. [redacted] told me the day before the incident, they, to include Jennifer, went to camp and took the guns to include the .22 magnum and went duck hunting. [redacted] told me he didn't see her handling the firearms, but he was sure she knew how to use them since she was from a village.

OFFICERS OBSERVATIONS/ACTIONS:

My contact with [redacted] concluded and he departed KPD.

At approximately 1005 hours, [redacted] arrived at KPD to speak with me. My contact with [redacted] was recorded and a copy of the recording was later entered into evidence. I informed [redacted] he was not under arrest, he didn't have to answer any questions and he was free to leave whenever he wanted. [redacted] told me he understood.

INTERVIEW:

In essence [redacted] told me Jennifer was in Buckland for a while. They were on and off in their relationship and decided to try and make it work. Jennifer wanted to come to Kotzebue because she didn't feel wanted anywhere. She was having a hard time in Point Hope too. When Jennifer came to Kotzebue she was staying at [redacted] residence, but she began to feel like she overstayed her welcome. Then she came to stay with him at his parents, but his parents didn't want her to stay there either.

[redacted] told me on Saturday, Jennifer was with [redacted] and on Sunday Jennifer came back wearing different clothes, her hair was muddy and Jennifer stated her and [redacted] got "jumped" by someone near Uutuku. Jennifer had scratches, scratches on her ankles and a scratch on her nose. Jennifer also had a bruise on her right eye. [redacted] couldn't remember any other marks on Jennifer. [redacted] told me Jennifer didn't know who assaulted her. Jennifer didn't want to go fishing because she was afraid to see who assaulted her. [redacted] told me he didn't know if anyone else assaulted Jennifer between Saturday and the day of the incident.

was hard on her emotionally. told me Jennifer tried to commit suicide before in Point Hope. told me Jennifer tried to shoot herself before with her brother's rifle and again with the shotgun. Jennifer told him there was a shotgun hole and she only told him and about it. was the person who stopped her and the shotgun went off. told me Jennifer was in Point hope from November to January. Jennifer did not tell how she was assaulted on Saturday, just where the assault took place.

told me there was just him, Jennifer, and in the residence. They got up and had breakfast and in the afternoon they went for a walk to help clean out a boat. They got back home at approximately 1400 hours. told me and his friend stopped by but they were drinking. They came by around 1500 hours and wanted to watch television. was trying to send diapers from Buckland, but the flight was cancelled. came by and dropped off diapers. told me after left, he and Jennifer were talking. Jennifer originally came to Kotzebue to turn herself in and serve three days in jail. Jennifer didn't want to though and she didn't feel wanted after he told her to turn herself in.

INFORMATION:

According to police records, Jennifer had a judgment on file referencing 2KB-17-00355CR where she had 30 days with 27 suspended for a DUI.

INTERVIEW:

In essence told me they had gotten into a verbal argument over turning herself in because she wanted to wait until Friday and he wanted her to get it over with. told her she had to turn herself in and go to Buckland because his parents didn't want her at their residence either. told me Jennifer had a DUI approximately six months ago. told me he didn't get physical with Jennifer. Jennifer didn't want to go to Buckland and she started crying. He told her not to cry in front of the kids and to go lay down in the room. and the kids were watching SpongeBob or some cartoon. Jennifer was in the room crying, she was really good at hiding her emotions until it all came out "like an explosion."

told me he was on the couch with the kids and Jennifer was in the bedroom for approximately one hour. went in the bedroom because he heard a gunshot. initially thought the sound was a "firecracker." He went in the bedroom to make sure and check on her and she was.... told me someone else called the police. Jennifer was still breathing, he couldn't find his phone so he ran next door. When he came back from telling a neighbor to call the police he was just holding her. told me the gun used was a .22 which was near a shotgun and another rifle in the room. told me the guns are not normally loaded. told me the day before they had gone to camp and they were using those guns.

When found Jennifer, she was at the foot of the bed and the gun was located on top of her head. then told me the gun was lying on her side and he moved the gun out of the way. told me when they came back from camp the gun had bullets in the magazine. He didn't think about it at the time, he just made sure there was nothing in the chamber. told me the other guns were not loaded. told me Jennifer was doing laundry.

told me he didn't know about the marks on Jennifer's neck and he didn't see any fingerprints or hand prints on her neck. didn't notice any marks around Jennifer's neck from last Saturday either.

When found Jennifer he did not try CPR or try to stop the bleeding, he was just holding her. told me he didn't physically assault Jennifer "that day" and the last time was in October. described the incident in October as when Jennifer came back from Buckland they were in his dad's "back house." They were watching television and drinking. She accused him of cheating on her and started to hit him so he held her away by her neck. told me the police were involved and he was arrested. told me since October, nothing like that has happened between them.

I inquired as to assaulting Jennifer on the day of the incident and he told me "it" happened after his and friend left. Jennifer didn't think he wanted her because he wanted her to turn herself in. Jennifer wanted to wait until Friday, but he told her she needed to turn herself in. Jennifer was going to stay at Nancy's. told Jennifer she needed to get it over with and Jennifer replied she was going to stay with until Friday. She tried to call and he held her back. Jennifer kept questioning him as to why he wanted her to go. Jennifer was mad at him and tried to slap him. Jennifer was drinking too. didn't know how much she had to drink but he had Vodka. hid the Vodka because she was drinking some without him.

told me Jennifer was slapping him on both sides of his head and ears. held her away by her neck and he didn't know how hard he was squeezing. When was holding Jennifer by her neck, she started to slap him harder. told me he pushed her away and he used one hand. Jennifer came back at him and he held her away again and pushed her away again. Jennifer stumbled, fell, got up and started again. He did the same thing and held her away. was unable to recall how much pressure he used.

told me when he pushed her the second time, he pushed her hard enough for her to fall. didn't know if the fall knocked her unconscious or not. The physical altercation happened in the kitchen of their residence. After that, told Jennifer to go into the bedroom. While Jennifer was in the bedroom, was laying down watching television with the kids.

told me he didn't think he caused her injuries and that was the reason he didn't tell me what had happened and he was trying to block out that day. told me the petechia and injuries to her neck were from him, but not her black eye. told me his fingerprints were not going to be on the trigger of the gun, they might be on the gun from handling it, but he didn't pull the trigger. told me he wanted to work with law enforcement; he would provide his known DNA and whatever I needed.

OFFICERS OBSERVATIONS/ACTIONS:

I obtained known DNA by using a sterile swab and swabbing the inside of his mouth. The sample was later entered into evidence.

told me he was uncertain as to how long Jennifer was in the bedroom before hearing the gu

nshot. told me he didn't remember how much ammunition was in the .22 magnum magazine and he didn't think anything of it. stated he should have unloaded it though. told me I would have to speak with about Jennifer attempting suicide in Point Hope. told me he didn't have much to drink that morning. He told me when he pushed Jennifer back the second time and she fell he couldn't remember if she got right back up or she stayed down for a while. The next thing he remembered was watching television and hearing the shot. also remembered telling Jennifer to sleep it off. told me he didn't pull the trigger.

In essence, [redacted] told he couldn't remember if Jennifer had hit him open handed or closed fist. [redacted] told me he did not remember if he went into the bedroom, but all he remembered was watching television with his kids. [redacted] told me there wasn't a struggle between him and Jennifer with the gun and he was watching television when he heard the gunshot. [redacted] also told me there was no altercation between him and Jennifer when she had the gun. [redacted] was unable to recall how much pressure he applied to Jennifer's neck.

When [redacted] discovered Jennifer, her head was towards the foot of the bed and she was laying on her right side in a semi-fetal position. [redacted] told me he couldn't remember where the gun was exactly located when he discovered her or where he moved it to. [redacted] did not recall if the rifle was difficult to move or if anything had been around or attached to the trigger.

[redacted] told me he would tell me if there was a struggle over the gun and if he would have done it he would have hid. [redacted] had only been back to the house to get his hat. [redacted] told me his was at home now. [redacted] told me he did not know where the bullet went. [redacted] was unable to tell me where Jennifer's bullet wound was.

[redacted] later told me he was having a difficult time speaking to me about the incident and departed KPD.

OFFICERS OBSERVATIONS/ACTIONS:

At approximately 1630 hours, search warrant 3AN-18-01538SW was granted by the Anchorage District Court which allowed a search of the residence known as [redacted] for the bullet believed to have caused the death of Jennifer. A copy of the warrant was later entered into digital evidence.

At approximately 1658 hours, Sgt. Cox, Ofc Cook and I arrived at [redacted] service. I met with [redacted] the owner of [redacted] referencing warrant [redacted]. My contact was recorded and a copy of the recording was later entered into evidence.

The bedroom was photographed in accordance to the warrant and I made a sketch to include measurements of the bedroom and items in the bedroom. A copy of the sketch was later entered into evidence. I did not observe any signs of a bullet hole in the floor, walls or any objects in the bedroom. However, I did observe a hole in the ceiling which was approximately 1/2 inch in size and appeared to be directly over where Jennifer had been discovered. Upon closer inspection of the hole, I recovered what appeared to be a .22 magnum bullet. The bullet was collected and later entered into evidence. I noted the bullet hole to be located in the Northeast corner of the room and approximately 39 13/16 from the North wall and 33 1/4 inches from the East wall. I also noted the bedroom as being 138 1/2 inches by 112 3/8 inches in size.

Upon completion of the warrant service, a copy of the warrant was left in the residence.

On 05/31/2018 at approximately 0908 hours, search warrant 3AN-18-01538SW was returned to the Anchorage District Court and a copy was later entered into evidence.
