THE COMPLAINANT STATES that on or about the 17th day of November, 2018  
 at or near Kotzebue in the 2nd Judicial District,  
 State of Alaska, the above-named Defendant did unlawfully commit the offense of Assault in the Fourth Degree if

The person recklessly causes physical injury to another person; AS 11.41.230(a)(1)

with criminal negligence that person causes physical injury to another person by means of a dangerous instrument; or AS 11.41.230(a)(2)

Victim's Name: Susanna Norton

Probable Cause Statement: This complaint is based on the observations and investigations of Sergeant Hughes of the Kotzebue Police Department. On 11/17/2018 at approximately 1200 hours, Eugene Taylor came to the Kotzebue jail to report an assault. Eugene reported that Susanna Norton had been assaulted by the defendant and was walking towards the 29 unit. The officer contacted Susanna and saw that her right eye was black and blue and swollen shut. Susanna was crying and reported pain in her stomach, back, arms and head. Susanna reported that her boyfriend, the defendant was drinking and she wanted him to stop so she poured out his beer. Susanna said the defendant became angry and grabbed her by the hair and drug her around the house. Susanna said the defendant kicked her repeatedly in the head, face, stomach and back. Susanna showed me her forearms which were swollen and told me she was holding her arms up to protect her head when the defendant was kicking her. Susanna was transported to Maniilaq Health center for treatment. Susanna reported that she is six months pregnant. The officer was unable to locate the defendant.

Request an arrest warrant be issued
