DEFENDANT, FORCED HIS WAY INSIDE THE APARTMENT. THE VICTIM STATED THAT SHE RAN INSIDE HER BATHROOM AND LOCKED HERSELF INSIDE; THE VICTIM ADVISED THAT THE DEFENDANT KICKED DOWN THE BATHROOM DOOR AND BEGAN PUNCHING HER SEVERAL TIMES ACROSS HER BODY AND THE FACE.

SUBSEQUENTLY, THE VICTIM FELL INSIDE THE SHOWER; WHILE IN THE SHOWER, THE DEFENDANT TOLD THE VICTIM, "WHERE IS THE KNIFE? GIVE ME THE KNIFE. YOUR LIFE WILL END TONIGHT; YOU'RE NOT GONNA SEE YOUR KIDS ANYMORE; WHERE HAVE YOU BEEN? WHO ARE YOU FUCKING.



THE VICTIM ADVISED THAT THE DEFENDANT STOPPED HITTING HER, WALKED OVER TO THE LIVING ROOM, AND SAT DOWN. THE DEFENDANT THEN BEGAN CRYING AND SAID. "WHY DID I HIT YOU? THIS IS DOMESTIC VIOLENCE. I'M GOING TO JAIL FOR A LONG TIME".

THE VICTIM ADVISED THAT SHE EXITED THE BATHROOM AFTER CLEANING HERSELF UP. THE VICTIM STATED THAT THE DEFENDANT TOLD THE VICTIM TO GET INSIDE HIS VEHICLE; SHE FOLLOWED THE DEFENDANT'S COMMANDS TO AVOID FURTHER VIOLENCE AND GOT INSIDE THE VEHICLE. THE VICTIM ADVISED THAT THE DEFENDANT DROVE TO SW 19TH AVE & SW 8TH ST "PRESIDENTE SUPERMARKET." THE VICTIM THEN ASKED THE DEFENDANT TO GET ICE FOR HER FACE. THE DEFENDANT WENT INSIDE THE SUPERMARKET, AND THE VICTIM FLED AND CALLED AN UBER TO HER SISTER'S HOUSE.

ON AUGUST 7TH, 2024, I MADE CONTACT WITH THE VICTIM VIA LANDLINE. THE VICTIM PROVIDED HER DISCHARGE NOTES; THE ATTENDING PHYSICIAN WAS [REDACTED] IN THE RELEASE NOTES, UNDER PROCEDURES PERFORMED ON THE VICTIM, IT IS WRITTEN THAT A LACERATION REPAIR WAS PERFORMED.
