Narrative

On September 14, 2023, at approximately 1307 hr., I assisted with a unit search in the Summit County Jail. While conducting a search in Unit Brovo Cell 4 I located a multiple page letter that appeared to be hidden in a book. The book was titled "10 Actual, Official LSAT Pretests". The letter was folded and placed in the middle of the book. Inmate Richins, Kouri (207839) was assigned Cell 4 and did not share the cell with any other inmates.

While inspecting the letter I could see multiple statements that appeared to be in reference to Case#22-L06363. The letter was written to her mother and appeared to be strategically written to coordinate a defense. Kouri gives her mother instructions to contact people involved in the case and what statements / testimony to give.

Kouri also solicits her mother to help her get contraband into the secured facility.

On September 14, 2023, at approximately 1307 hr., I assisted with a unit search in the Summit County Jail. While conducting a search in Unit Brovo Cell 4 I located a multiple page letter that appeared to be hidden in a book. The book was titled "10 Actual, Official LSAT Pretests". The letter was folded and placed in the middle of the book. Inmate Richins; Kouri (207839) was assigned Cell 4 and did not share the cell with any other inmates.

While inspecting the letter I could see multiple statements that appeared to be in reference to Case#22-L06363. The letter was written to her mother and appeared to be strategically written to coordinate a defense. Kouri gives her mother instructions to speak to Ronney and give statements / testimony.

Kouri writes instructions of what she wants Ronney to say. After giving these instructions she states: "*Rerword this however he needs to, to make the point just include it all*"

The letter states for Kouri's mother to talk to Ronney about this in person because she's worried her mother's house and phones are being bugged / monitored. The letter then states:

"Tell him I need him to do this. Bring me home and then we will get those damn bitches!".

Kouri's letter then gives instruction to text or call Lotto stating:

"Tell him do not text me anything about us doing things together ever! Like church, skiing, trips! nothing that puts us together, it doesn't look good. Were so close to the end, lets push through. Have the conversation with Ronney before he meets with Skye. Then tell him to tell Skye at the meeting about the conversation. Hang in there, were almost there. Love you to the moon".

Kouri states in the letter 2 times "Take vague notes of all this so you remember before you walk the dog". She writes this in bold letters as the title of the letter and again approximately half way through the letter.

Kouri's letter then talks about real estate and getting Morissa's, Chelsea's, and her mother's house taken care of. She requests her mother to ask Lotto to do a home equity line of credit on his house to help her out. After this statement she writes:

"Remember I told you one way to get at Katie is going through my phone and finding a picture of her girls even with the boys. Print 15 copies and send them out anonymously to different media companies. Obviously don't email the pictures so its not traceable. She would be livid if it got out to the public. You would just have to do it sneakily and be careful. She would try and trace it back to you. If not, no worries!".

The letter states that Skye is having the girls do an interview with Good Morning America. Kouri gives instructions stating:

"Please tell Chelsea to bring up that he hasn't been to church in the 13 years she has known him and that Eric would brag to her about how much he drank and did pills in high school". Tell Kelsey to say "Eric always wanted Kouri to go down form him" for example he would put drugs in her suitcase when they would travel together so if anyone got caught it was Kouri. He would put it in her bag right before they left the house so Kouri didn't know. Then when we would land wherever, Eric would take them out of her bag and Kouri would be pissed and they would argue about it. Tell Kelsey to say how Eric didn't care and would just laugh about it and say "well I can't get in trouble.". as if it was okay that I got in trouble. Have Selma talk about Eric in Spain not being able to

drink so he was looking for drugs the entire time. Explain the drink the waitress gave him and how I called his doctor and went to the pharmacy immediately. "Have Ali talk about how the sisters have always been jealous of me because anything they could do, Kouri could do better. Being a mom, college, stay at home wife until she built a million-dollar company, a nice house, car everything she had, they wanted. This comes down to jealousy, money, and Eric's partying that they don't want to acknowledge and sadly an accidental overdose".

The letter states for her mother to work on the gun receipts so they can file charges and the prosecutor not do anything about it, to use in her defense.

Kouri requests for her mother to buy a box of Crest White Stripes and put the strips in an envelope. She states:

"Will you buy a box of Crest White Strips, open them up, put in an envelope and have Skye give them to me. You can tell her what's in the envelope, I'm sure she won't care. I'll make sure they can't be found in my cell. My teeth are yellow from so much coffee and tea all day".

Kouri finishes the letter by stating:

"I love you. I love you, hang in there, we're getting there, slowly, you're the best mom in the whole world! It's so lucky to have you!".

The following pages appear to be a check list for her mother going over everything stated in the letter.

Due to threats to the public, and the security of the jail the letter was confiscated and placed into evidence.

A photo of the book where the letter was found has also been attached to this report.

Inmate Richins, Kouri was locked down pending discipline and issued a violation for the following jail rules:

VC-1-J - Violation of any law or conspiracy to violate the laws of the United States or the State of Utah

VC-2-K - Interfering with an investigation: making false statements

VC-3-N - Manufacture, possession, or transport of, or other trafficking in contraband.

No further details.
